ORDER

In G.O. Ms. No. 50 I&CAD (PW) Dept., dt. 30-1-90 read with G.O. Ms. No. 295, I&CAD (PW) Dept., dt. 20-6-90, orders were issued extending the powers delegated in G.O. Ms. No. 351, PWD (PW) Dept., dt. 13-8-75 for a further period of (5) years from 14-8-1986 to 13-8-1991 duly enhancing the ceilings as indicated below from date of issue of the orders for sanctioning the amounts for maintenance and special repairs to special tools and plants these powers are applicable to Engineers under the control of irrigation and command area development (Projects Wing) Department.

- 2. The powers as delegated in the G.O. 2nd read above on 13-8-1991. The Chief Engineers have submitted proposals extension of powers beyond 13-8-1991 and some of the Chief Engineers including Chief Engineer, Mechanical have request make the powers permanent.
- 3. The Government after careful examination of the hereby extend the powers already delegated in G.O. Ms. No. 50, Irrigation & CAD (Projects Wing) Department, dt. 30-1-1990 with G.O. Ms. No. 295, irrigation & CAD (Projects wing) Department dt. 29-6-1990 for a further period of three years beyond 13-3-1991 and ratify the action of the Superintending Engineers and Executive Engineers in having exercised the powers beyond 13-8-1991.

- 4. The Chief Engineer, Mechanical has requested to extent the powers enjoyed by the Superintending Engineers and the other Superintending Engineers and Executive Engineers working in irrigation Circles and also to rectify the anomolies that arose due to the issuance of enhanced powers in G.O. Ms. No. 50, Irrigation & CAD (Projects Wing) Department dt. 30/1/90. These proposals are separately under examination.
