ORDER:-

In G.O. Ms. No. 2651 P.W.D. dated. 9-12-66 G.O. Ms. No. 617 P.W.D. dt. 18-4-69 and G.O. Ms. No. 533 P.W.D. dated: 27-3-70 power have been delegated temporarily to the Chief Engineers and Superintending Engineers (IB & R&B) for according administrative approval to estimates for first electrical installation upto Rs. 50,000/- and Rs. 20,000/- respectively. But the Chief Engineer and Superintending Engineers have no powers for accordingly technical sanction to estimates for electrical works. Consequent on the reorganization of the office set up of the electrical engineer (General) at Guntur the work of electrical installations to Government Buildings has been entrusted to the Executive Engineers (Roads and Buildings) of the respective divisions and certain powers in respect of electrical works have been delegated to the Executive Engineers (IB) in the state. According to the powers delegated the Executive Engineers can accord technical sanctions to detailed estimate for electrical works upto Rs. 15,000/-.

In pursuance of a resolution of the committee of Chief Engineer the Chief Engineer (Major Irrigation and General) has proposed that powers may be delegated to the Superintending Engineers for according technical sanction to detailed estimates for electrical works upto Rs. 50,000/-. He was also proposed that full powers may be delegated to the Chief Engineers in this regard.

The Government accept the proposals of the Chief Engineer (major Irrigation and General) and delegate the following powers temporarily upto 30-7-73.
