# **ORDER**

The Government has considered the representations made by the A.P. Waddera, Waddi and Waddilu Welfare Association read above and in partial modification of the existing orders issued in G.O. first read above and as clarified in Govt. Memorandum second and third read above issue the following revised orders for entrustment of works belonging to irrigation & CAD Projects wing Departments to the co-operative societies and individuals belonging to scheduled castes, Scheduled Tribes and Wadderas as detailed below:-

- i) Registered societies belonging to scheduled castes, S.Ts., and Wadderas shall be exempted from payment of Earnest money deposit for works costing upto Rs. 20,00 lakhs (Rupees Twenty Lakhs only).
- ii) Individuals belonging to Scheduled castes, Scheduled tribes and Wadderas shall be exempted from payment of Earnest money Deposit for works costing upto Rs. 20,00 lakhs (Rupees Twenty lakhs onlt).
- iii) Works shall be letout to the societies/individuals belonging to S.Cs and S.Ts and Wadderas on nomination basis upto a limit of Rs. 25,000/- by the E.Es and upto a limit of Rs. 50,000/- by the S.Es. The powers of C.Es. in entrustment of works on nomination basis shall be limited to Rs. 5,00 lakhs (Rupees five lakhs only) in case of societies belonging to scheduled castes, Scheduled Tribes and Waddera and Rs. 2,00 lakhs (Rupees Two lakhs only) in the case of individuals.
- 2. This order issues with the concurrence of Finance and Planning (P. Dept. vide their U.O. No. 313/F.VII/94-1 dt. 11-8-94.

You are aware that the Govt. vide G.Os. cited above have provided various concession to the labour contract Coop. Societies organized for the benefit of Scheduled Castes and Scheduled Tribes and Backward classes (Wadderas) etc., in awarding civil contract works by various Engineering Departments and work awarding authorities.

The concessions extended in the above orders include registration of L.C.C.Ss. as Class – II/III contractors in the office of the Superintending Engineers and

Executive Engineers (Work awarding authorities) without solvency certificate, exemption from payment of E.M.D., earmarking 15% of the works for the societies and allotment of works on nomination basis.

There are representations from some of the societies that the work awarding authorities are not following the above Govt. orders and not reserving works to the societies. This was brought to the notice of the Govt. by the Commissioner for Cooperation and Registrar of Copoperative Societies/Chairman, A.P. State Coop. Labour Contract Societies Federation Ltd., Hyderabad with a request to issue strict instructions to the work awarding agencies to implement the orders of the Govt.

The Chairman of the State L.C.C.Ss. federation. Ltd. Hyderabad vide reference 3<sup>rd</sup> cited has informed that the Govt. vide Memo. No. 22511/COD/93-1, dated. 13-5-93 and Memo. No. 32077/COD/93-3, dt. 30-9-93 of irrigation & CAD Dept., have directed all the Chief Engineers to issue strict instructions to the work awarding agencies to implement the Govt. orders by extending all the concessions to the L.C.C.Ss. The Chairman has further requested the Dist. Collector that the above Govt. instructions may be brought to the notice of all the work awarding authorities.

In this regard, I further inform you that in the Managing committee meeting of the Dist. Labour Contract Coop Societies Federation Ltd., Warangal held on 16-8-1993 under the Chairmanship of the Dist. Collector, it was resolved to request all the Executive Engineers/Superintending Engineers (Work executing authorities) of various Engineering Depts., to strictly implement the G.Os. in allotment of civil contract works to the L.C.C.Ss. (copy enclosed).

In view of the above, I request you to kindly implement the concessions extended to the SC/ST/BC(Wadderas only) based L.C.C.Ss. in the G.O. Ms. No. 475 HMA & UD. Dept., dated 28-8-1989 and G.O. Ms. No. 398 I & CAD Dept., dt. 5-9-1990.

In this regard, I further state that, to eliminate practice of allotment of works to the bogus/defunct L.C.C.Ss. you may obtain a report from the concerned Divnl. Cooperative Officer on the working condition of the society before allotment of any contract work to the society in the enclosed proforma which is to be issued for each financial year. The jurisdiction of Divnl. Cooperative Officers of the District is coterminous with the revenue divisions in the district.
