In the reference cited, the Joint Director of Works Accounts, W&P, Hillcolony seeking for clarification on the inclusion the provision towards labour welfare cess @ 1% in the estimates on the basis of U.O.Note.No.4763/PFS/F.8(A1)/08-4 of Finance(W&P) Department, dated 28.02.2008 addressed to I & CAD on the above subject (copy enclosed). So far no Government Orders are received on the U.O.Note. But the Superintending Engineer, N.S.Dam Circle, Hillcolony has included the above 1% cess in the estimates and also incorporated condition for repayment in the agreements also duly quoting the reference 1st cited.

I submit herewith the detailed report in the W.P.No.26939 of 2009 filed by N. Thirupathi Rao & Compar the Hon'ble High court of Andhra Pradesh, Hyderabad for payment of Labour Cess of an amount of Rs.6,25,806/-. work of 'Formation of New Tank across Salpalavagu, near Komaticheruvu (Village), Kasipet (M) Adilabad (Dist entrusted to M/s. Thirupathi Rao & Co. vide Agreement No.2/2004-05, Dt: 08-04-2004 an amount of Estimat Rs.2,44,35,861/- at 25.29% less over E.C.V priced with S.S.R2002-03.

The contractor has represented for amount of 1% labour cess which was added in Revised Technical san The final bill 1% Cess was added by incorporating the provision in the Revised Estimate 2009-10 and in scruting amount of 1% labour cess was deleted as per Government Rules. This office has disallowed the amount a Government rules and aggrieved by the contractor has filed the W.P. No.26939 of 2009. A brief note was submit G.P for (Finance & Plag) Andhra Pradesh Hon'ble High Court to safe gourd the interest of Government.

The W.P. came up for hearing on 18-12-2009 before his lordship Mr. Justice L.Narsimaha Reddy. T has informed vide reference 5th cited has directed to follow the judgment in the High Court batch cases in no.11269/2009 and to report compliance.

In this regard, it is to submit that there are no clear orders from The Government, that adding of 1% cess to the estimate is to be implemented as per instructions vide reference 2nd cited, the Director of works Ac in the letter 3rd cited has clearly brought to the Government clarification. That adding 1% Cess in the estimate condition for repayment as the agreement is irregular.

The same was brought to the notice of the G.P. for defending the case in Govt. favour.

Therefore it is requested to issue instruction whether to pay the amount or not by obtaining Govt. ins so as to inform the GP and to Hon'ble High Court early action is solicited in the matter as it is urgent to be su in the Hon'ble High Court.

In continuation of the U.O.Note cited, in which it was requested to Issue Orders for making L.S. provision @ 1% towards, Labour Cess in all the estimates sanctioned from 26.6.2007, the following guidelines are communicated in respect of ongoing works:

- (i) In respect of ongoing works, wherever agreements do not contain the clause relating to the condition of the Building and other construction Workers Cess Act, an amount of @ 1% of the amount will be added to the estimates and the estimates revised accordingly for all payments made after 26.6.2007.
- (ii) In respect of agreements which provided that the Contractor shall pay Cess at the rate not exceeding 2% of the cost of Construction under the Building and other Construction Workers Cess Act, 1996, the Contractor has no option but to Pay Cess by way of deduction at source effective from 26.6.2007.

It is requested to issue common Order applicable to all Engineering Departments on the above lines .

His Lordship was pleased to dispose of the writ petition directing the Executive Enineer I&CAD I.B Division, Mancherial. Adilabad District, and you to dispose of the representation, which the Writ Petitioner said to have submitted on 16-11-2009, with in 2 weeks from the date of the receipt of copy of the order in writ petition. (a copy of the representation is enclosed herewith).

I may also bring to your notice, that the Hon'ble High Court in batch cases in WP.No.11269/2009 and batch held that

"The Respondents shall include 1% Cess in the estimates for the works, which they propose to under take, if the work continues for or beyond 12 moths, and involves engagement of workers or more" and

"The Respondents shall not deduct any annual towards, cess, unless the corresponding amounts is included in the estimate'.

Therefore, you are advised to follow the direction issued by the Hon'ble High Court in the above W.P.No.26939/2009.
