ORDER:-

In the reference 1 to 6 read above, Govt. according sanction for further continuance of the Temporary staff of S.E. Divn., Visakapatnam, Q.C.V. & E Circle Dowlaiswaram, M&MPI Divn. Ongole, GNSS Divn. Pulivendula, IPI Divn., Warangal & T.R.S. Divn., Hyderabad with its sub-divisions upto 28-3-1997.

- 2. The ENC (AW) Hyd., has submitted proposals in his letter 7th read above for conversions of above existing divisions as Quality Control Divns., to look after the Quality Control operations on all the works including NABARD and World Bank aided works in the state except major projects where separate quality control divisions are existing.
- 3. Government after careful examination of the proposals here by accord sanction for the conversion of divisions as indicated below with the works allocated.

- 4. The sub-divisions will be located according to the requirement keeping in view of the work load etc.
- 5. The 4 Quality Control Divns., in Zone-I, II, III at 1) Visakapatnam 2) Dowlaiswaram 3) Vijayawada & 4) Ongole will be under the administrative and technical control of existing S.E., Q.C.V & E Circle, Dowlaiswaram.
- 6. The remaining 3 Q.C., Divins., in Zone0IV, V & VI at 1) Pulivendula 2) Warangal & 3) Hyderabad will be under the administrative and technical control of the existing S.E., Spl. Designs Circle, Hyderabad in addition to the existing 4 designs divisions.
- 7. The S.Es., Dowlaiswaram & Hyderabad will report to the C.Es., Major, Medium & Minor Irrigation depending upon the nature of the work on the Quality Control aspects.
- 8. The Vigilance checks on the works based on specific complaints will be attended by the two S.Es Vigilance working under the ENC (AW) I& CAD Deptt., Those will also conduct the audit and deal with the administrative matter of the Quality Control Organisation and report directly to the I&CAD.
- 9. The PAOs/DTOs/E.Es should ensure that all the works are checked by the concerned Q.C. organization before admitting the bills for payment.
- 10. The details of the staff sanction for the above divisions are as indicated in the annexures I to V of this order.
- 11. The staff sanctioned in para 3 above shall be eligible in draw usual pay & allowances admissible order the rules in force. The existing infrastructure facilitate will be continued to the utilized by the newly formed divisions Govt., any change.
- 12. The expenditure for the staff sanctioned to this order shall be debitable to the Head of Accounts as indicated in the Annexure to this order.
- 13. In view of the urgency expressed by the ENC (AW) permission was accorded in Govt. Memo. No. 28432/Irr. (2)/97-1, dt. 30-8-97 for the diversion of S.E. Divn., Visakhapatnam as Q.C. Divn., Visakhapatnam with effect from 1-7-97. These orders will be intimated with effect from 31-7-97 A.N.
