#### **ORDER:-**

In the G.O. Second read above, the Government after taking into consideration the representations of the Chief Engineers and the recommendation made by the informed consultative committee ordered for the ennancement to the maintenance charges from Rs.6/- to Rs.8/- per acres per annum in respect of Minor Irrigation works schemes and from Rs.6/- to Rs.9/- per acre per annum in respect of Major and Medium Irrigation projects/schemes/works.

- 2. The Chief Engineer (Major Irrigation and General) has brought to the notice on the Government that the rated Rs.9/- per acre per annum is utterly inadequate in view of increased cost of labour materials and the salaries of work-charged establishment etc. The Chief Engineer (Major Irrigation and General) has also stated that the issue has been re-examined and minimum rate of Rs.16/- per more annum is considered necessary or proper and effective maintenance irrigation system.
- 3. The Government considered the proposal of the Chief Engineer (Major Irrigation and General) and decided to enhance the maintenance charge or Major and Medium irrigation systems from Rs.9/- to Rs.10/- per acre per annum.
- 4. Accordingly Government hereby order, in partial modification of the orders issued in the G.O. second read above that the present rate of Rs.9/- per acre per annum in respect of Major and Medium irrigation systems be enhance to Rs. 10/-(Rupees Ten) per more per annum.
- 5. This order issues with the concurrence of Finance and Planning (Finance-Ex.PWD) vide their D.O. No. 3152/1772/Exp.PWD/77-1 dated. 11-11-1977.
