## **ORDER:-**

The Engineer-in-Chief (IW-PMU) in his letter read above has submitted that the Government have sanctioned to take up Operation & maintenance and Minimum Rehabilitation Works in the following GOs.

- 1. G.O. Ms. No. 26, I&CAD (APERP) Dept., dt. 6-3-99 Rs. 30.95 Crores.
- 2. G.O. Ms. No. 27, I&CAD (APERP) Dept., dt. 6-3-99 Rs. 165.84 Crores.
- 3. G.O. Ms. No. 53, I&CAD (APERP) Dept., dt. 8-4-99 Rs. 32.46 Crores.
- 2. The Engineer-in-Chief has also informed that the Water Users Associations and Distributory Committees are to take up works in their areas of operation against the amount sanctioned to them during the current closure period of 1999-2000. The details are as follows:

- 3. The Engineer-in-Chief has reported that the works to be taken up by Water Users Associations and Distributory Committees are to be insured as per the conditions of the Agreements in clause A1, A2, A3, A4&A5. The Engineer-in-Chief has also reported that he had discussions with the Nationalized insurance companies and proposed to insure the works at a premium rate of 0.39% of the cost of works to cover the following.
- (a) Basic Cover towards unfortunate accidental damages to works arising out of natural calamities like, floods/cyclones/lightening during execution of works.
- (b) Maintenance Cover for six months after completion of work.



- (c) Third party liability upto 31-12-99 to aggregate limit of Rs. 11 lakhs with per occurrence limit of Rs. 50,000.
- (d) Fidelity Cover to an extent of Rs. 70 lakhs with limit per occurrence to a maximum of Rs. 20 lakhs.
- 4. Government after careful consideration hereby order that the works undertaken by Water Users Associations and Distributory Committees under GOs referred to in para 2 above may be got insured through the nationalized Insurance Companies at a premium rate of 0.37% of the cost of works. The insurance shall cover the following.
- (a) Basic Cover towards unforeseen accidental damages to works arising out of natural calamities like, floods/cyclones/lightening during excavation of works.
- (b) Maintenance Cover for six months after completion of work.
- (c) Third Party Liability upto 31.12.99 to an aggregate limit of Rs. 11 lakhs with per occurrence Limit of Rs. 50.000.
- (d) Fidelity Cover to an extent of Rs. 70 lakhs with limit per occurrence to a maximum of Rs. 20 lakhs.
- 5. The expenditure on insurance may be booked to the work estimate concerned. The insurance premium paid is to be recovered from the amounts payable to the WUAs and DCs on the works and shall be deducted from the advances given to the WUAs/DCs.
- 6. The Engineer-in-Chief (IW-PMU) is directed to issue necessary instructions in this regard to the Chief Engineers and Field Officers concerned to get the insurance processed at District level. The Engineer-in-Chief shall take steps to provide insurance cover by calling for a meeting with the Nationalized insurance companies.
- 7. The Engineer-in-Chief is also directed to see that the above insurance companies notify their nodal officers to process the claims at the District level and lay down procedures for claims and reimbursements.
- 8. This order issues with concurrence of Finance & Planning (PW) Dept., vide their U.o. No. IS666/F4(1)99-1 dt. 9.4.99.
