While enclosing a copy of Government Memo No.584/F.8(1)/2005-06, dated 21.04.2006, which was already communicated to all JDWAs and PAOs/APAOs vide this office endorsement No. DWA/Hyd/Sn.II/A5/2006-07/1490, dated 25.10.2007, all the JDWAs and PAOs/APAOs are directed to observe the following points while admitting the work bills.

Permission of labour amenities i.e., 3% provided in the estimate is to be allowed based on production of certificate obtained from Labour Department where the labour component cost is more than Rs. 20 lakes if the following conditions are fulfilled.

a) Where the labour component on item of work excluding cost of material worked out to more than 20 Lakhs and engaging more than 100 for more than one month on a 'particular work.

(OR)

b) Otherwise the provision for labour amenities loaded in the estimate is to be recovered from the bill.



Government in the references 1<sup>st</sup> to 3<sup>rd</sup> cited have, from time to time, issued orders making provision for importation of Labour and Labour Amenities at the time of preparing the estimates. Out of 13% of Labour Amenities & Labour Importation, 10% is for labour importation

- 2. A meeting was held on 27.4.2005 in the Chambers of the Principal Secretary, Finance (Works & Projects) Department, for reviewing the provision of Labour Importation and Labour Amenities, and after detailed discussions, it was decided that the limit may be raised to Rs.20.00 lakhs as against the existing limit of Rs.5.00 lakhs. Accordingly, orders were issued vide G.O. fourth cited, providing 10% towards Labour Importation in case of works where labour component on items of work excluding cost of materials works out to more than Rs.20.00 lakhs. Further the provision towards Labour Amenities has also been examined. It is decided to insist for verification of labour amenities by the officials of Labour Department in cases where more than 100 labourers for more than one month on a particular work are engaged.
- 3. The matter has been examined in consultation with Irrigation & CAD Department, Board of Chief Engineers and Commissioner of Labour and it is hereby instructed that verification of Labour Amenities by Labour Department wherever provision for Labour Amenities is made in the item of work, be insisted in all cases. Certificate to the effect that labour amenities as prescribed in all such cases are actually provided on site by the officials of Labour Department, is necessary for admitting work bills for payment in which Labour Amenities is allowed. Based on production

of certificate that labour amenities under Labour Act are adequately provided by the Contractors, payment towards this component would be allowed to the contractors by the Pay and Accounts Officers, in respect of all works costing more than Rs.20.00 lakhs and engaging more than 100 for more than one month on a particular work. When such certificate from the officials of Labour Department is not enclosed with the bill, amount equivalent to Labour Amenities component provided for the item should not be claimed by the Drawing and Disbursing Officer concerned and Pay and Accounts Officer shall not admit such claims.
