ORDER:

In the G.O.1st read above, orders were issued for payment of Price Adjustment for Steel/Cement, limiting further to the lowest rate of invoice or rate fixed by the price adjustment clause whichever is less.

2. The Builders' Association of India in their representation 2nd read above has requested for withdrawal or cancellation of the G.O.Ms.No.269, T.R & B Dept., Dated:15.09.2008.

3. In the letter 3rd read above, the Board of Chief Engineers (BOCEs) who has been consulted in the matter has opined that the procedure for limiting the lowest rate of invoices or the rate fixed by price adjustment clause whichever is less may lead to different rates for various works in the same month and will lead to legal and audit problems and recommended the stipulation of payment with reference to invoice to be withdrawn. Besides price adjustment for all other items are not based on invoices. Also, different prices may be paid by contractors for different quantities of the same material.

4. Government with these considerations and after careful consideration of the matter hereby withdraw the G.O.Ms.No.269, T.R & B Dept. Dated:15.09.2008.

5. All the Heads of Department connected with Engineering works shall take further action accordingly.
