In the reference 2<sup>nd</sup> cited, the Director of State Audit, A.P. Hyderabad had insisted on presentation of two certificates from the pension sanctioning authorities one towards counting the pre - absorbed Work Charged service before becoming Government Employees permissible to be counted for purpose of pensionary benefits In the case of contributing and the other towards non contributing EPF Scheme, as is applicable.

2. Therefore, all the Departments in the Secretariat and Heads of Departments are requested to furnish the following (2) certificates by the drawing and disbursing officers and pension sanctioning authorities under their control while forwarding the pension proposals of those who have benefited as per orders in the reference 1<sup>st</sup> cited.

(i) Certified that the individual has exercised option in terms of G.O.Ms.No.212, Irrigation & Power Department, dated 29-3-1979 and G.O.Ms.No.130, Irrigation & Power Department, dated: 18-3-1981 that his/her pre Work Charged Establishment service is permissible to be counted for purpose of pension and an amount of Rs. -----, being the Employer's Share of contribution to E.P.F. Scheme has been credited to Government Account vide Challan No.-----dated - -----vide entry in Service Register at pages ----- and there is no objection to count pre absorbed Work Charged Service for the purpose of Qualifying Service.
