ORDER:-

In the G.O.1st read above orders were issued to adopt Price Adjustment clause for Steel, Cement, Bitumen & POL for works with a value of ore than Rs.50.00 lakhs and for which the stipulated period to complete the work as per Agreement is more than six months.

2. Now, under the circumstances reported by the Engineer-In-Chief(PR), Hyderabad in his letter 2nd read above, Government after careful examination hereby accord permission to adopt Price Adjustment clause for Steel, Cement, Bitumen & POL for all works irrespective of cost and Agreement period, subject to the following condition:-

- i. Price Adjustment shall be both for increase and decrease in the period of the works completed within the original Agreement period.
- ii. In addition, the Price Adjustment shall be for valid extension given or natural calamities duly limiting to the actual period/ days lost and for portion of work where work is delayed due to land acquisition/ shifting of utilities (this shall also be limited to actual length affected).
- iii. The Price Adjustment shall be effective from the date of Agreement for the balance items of the works executed after 01.09.2004 for which final bills for not paid, and for all future works.
- iv. The variation clause will be when the variation in rates is more or less than 5% of the rate provided in the technical sanctioned Estimate based on which bids are invited or All India Wholesale Price Index as stipulated in the G.O. 1st read above on the date twenty eight days prior to closing date of submission of bills, whichever is advantages to the Department.
- v. For works taken up under Externally Aided Projects, the guidelines specified thereon and to be followed.

3. The Engineer-In-Chief, PR, Hyderabad shall take necessary action accordingly.

4. These orders are issued with the concurrence of Finance (Expr. PR&RD) Dept. vide their U.O. No. 7390-A/103/A1/Expr. PR&RD)/07, Dt:30.03.2007.
