ORDER:-

In the reference 2nd read above, the Chief Engineer, major Irrigation, Hyderabad has stated that Government communicated guidelines for allocation of water tax collected during Kharif and Rabi in irrigation systems among the water users associations, distributory committees and Project Committees under para 6 (iii), it was instructed that based to adjust amounts due to different farmers organizations within one month of the end of quarter and on the basis of said proceedings, the concerned Treasury officer will issue cheques in favour of water users association/distributory committee/project committee/gram panchayaths in the ration fixed by irrigation department from year to year and also stated the Project Committees are not yet formed in the systems and the irrigation department (concerned Superintending Engineer) is discharging the duties of project committee. As such it is necessary that the amount allocated for project committees is to be remitted to concerned assistant pay & accounts officer/Pay & accounts officer of the system and kept under the Superintending Engineer concerned for utilization.

2. Since the Head Works are to be treated as comment to the districts irrigated under the system, it is necessary that some percentage of the amount of cess collected and apportionable to project committees in the districts concerned is to be kept at the disposal of the Superintending Engineer concerned for utilization on O&M of head works, payment of C.C. Charges and others etc. The Sir Arthur Cotton Barrage across the Godavari, Prakasam Barrage across the Krishna, certain dams on Pennar and Tungabhadra are common to more than one district under the projects.

3. In view of the request of the Chief Engineer, major Irrigation, Hyderabad that para 6 (iii) of G.O. Ms. No. 115 Revenue (LR.3) Department, dated. 13-2-2001 may please be further amplified with detailed instructions to the treasury officer, to issue cheques for the amount under project committee to the Assistant Pay & Accounts Officer/Pay & Accounts officer concerned as per percentage distribution indicated in the statement duly enabling the concerned Superintending Engineers to take up works and book the expenditure accordingly under Project committee, the Government after careful examination of the proposal of the Chief Engineer, Major Irrigation, Hyderabad hereby amplify the orders in para 6 (iii) of G.O. Ms. No. 115, (Lr.3) Department, dated. 13-2-2001 as follows.

(i). Based on the actual collection, Mandal Revenue officer will issue proceedings every quarter to adjust amounts due to Waters Users Associations/Distributory

Committees/Project Committees/gram Panchayats within one month of the end of quarter and on the basis of the said proceedings, the concerned treasury Officer will issue cheques in favour of waters users associations/distributory committees/ Gram Panchayats in the ratio fixed by the irrigation department from year to year.

(ii). The Treasury Officer are further instructed to issue cheques for the amount under project committee to the Asst. Pay & Accounts Officer/Pay & Account officer concerned as per percentage distribution indicated in the Annexure to this order so as to enable the concerned Superintending Engineers to take up works and book the expenditure accordingly under Project Committee.

3. This order issues with the concurrence of Finance & Planning (PW) Department vide their U.O. No. 3202/F.V(2)/2001-1, dated. 14-5-2001.
