ORDER

In the G.O. first read above Govt., have enhanced the monetary of Rs. 4000/- per annum to Rs. 6000/- per vehicle per annum towards expenditure on repairs including tyres and tubes for inspection vehicles (light Vehicles) and from Rs. 8000/- to Rs. 12000/- per annum for heavy vehicles.

The Government, have carefully examined the proposals submitted by the Chief Engineer, Nagarjunasagar right canals for enhancement of the above monetary limit in view of the orders issued in the G.O. 2nd cited. They accordingly in supersession of the orders contained in para 2 (i) of G.O. Ms. No. 215, Irrigation (PW) Department dt. 3-6-1983 issue the following orders.

(i) The raise the limits prescribed in G.O. first read above for expenditure on repairs including tyres and tubes from Rs. 6000/- to Rs. 8000/- per annum for inspection vehicles (light vehicles) and from Rs. 12000/- to Rs. 15000/- per annum for heavy vehicles.
