#### **ORDER:-**

According to orders issued in the G.O 1<sup>st</sup> read above, the Earth Work Excavation involving 1000 cum and above is to be executed necessarily by machinery only, and payment regulating adopting machinery rates.

Government observe that the rate structure for earth work excavation in all classification was formulated years back and based on deployment of labour and there was vast gap in the rate structure between manual and machinery excavation, where manual rate is abnormally high. Government further observe that in earth work excavation large scale manipulation was being done and higher rates are being fixed. Taking this into consideration, the I&CAD Department has made a thorough study and has given more reasonable rate structure effective from November, 2003 in their memo 2<sup>nd</sup> cited. The Board of Chief Engineers however while fixing up the SS rates for the year 2003-2004 did not take this into consideration and fixed higher rates for earth work excavation giving room for boosting up of estimate. The formula followed by the board of Chief Engineers was not rational and did not take into consideration the prevailing rates as which machinery is available for lease and the economics of scales involved in large scale works. There was an uproar over the abnormal rates including coverage in press now this can be manipulated to the advantage of the contractors. Keeping this in view and at the request of Irrigation Department Government in Finance (W&P) Department have convened a meeting with all the Engineers-in-Chief/Chief Engineers of all Engineering Departments. In that meeting it was decided that the rates fixed by irrigation department in their memo 2<sup>nd</sup> cited will be adopted by all the Engineering Department and the SS rates approved by the Board of Chief Engineers as prescribed in the preamble at item 11.0 of SSR for 2003-2004 as far as Earth work Excavation be kept in abeyance. Accordingly instructions have been issued in Memo 3<sup>rd</sup> cited. Subsequently Government in I&CAD (PW-

- SRSP) Department have approved a rate structure for hard rock and boulders of more than 3 cubic meters in size in the Memo 5<sup>th</sup> cited.
- 3). Government further observe that the procedure being followed by board of Chief Engineers in terms of fixation of rates does not look scientific and it needs a through review involving people with certain financial back ground, so that the rates are more in with the existing market rates. Accordingly a committee has been constituted to look into this and evolve scientific and more reasonable rates vide G.O.  $6^{th}$  cited.
- 4). In the mean while, in order to have uniformity and economy in the cost, Government after careful consideration hereby order to adopt the following rate structure as prescribed by the Irrigation Department in the Memos first and fifth cited by all the Engineering Departments through out the state and that the earth work excavations must be only by machinery.

1.	Excavation of all soils upto SDR	Rs.16.24 per cum
2.	Excavation in HDR, I&II	Rs.24.36 per cum
3.	Excavation in F and F rock	Rs.48.36 per cum
4.	Excavation of hard rock and boulders of more	Rs.96.72 per cum

5). The rates ordered in above para are applicable in respect of all types of earth work excavation involving a quantity of 1000 cum and above.
