ORDER:-

1. In the G.O. 1st read above, orders were issued Delegating powers to the Executive Engineers of workshop & Machinery divisions and the Executive Engineers of field machinery divisions under the control of the Chief Engineer, Mechanical and pertaining to the Projects under the administrative control of Irrgn (PW) Dept for purchase of spares and stores by constituting a stores purchase committee prescribing the accounts procedure and payment of advance etc.

In the letter last read above, the Chief Engineer, SRSP., has reported that on abolition of the post of the Superintending Engineer, Mechanical circle, SRSP project with effect from 1-8-89, the machinery yard sub-division of works and machinery division, LMD is attached to stores division at Pochampad and the sub-division is incharge of works like repairs to light machinery, jeeps, cars, lorries, gates etc.,
3. As the Executive Engineer, Stores Division, Pochampad is not empowered to make purchase as per the orders issued in the GO 1st read above, the work in machinery yard of sub-division is hampered. The Chief Engineer, SRSP, has, therefore, requested for extension of the powers delegated in the GO 1st read above to the Executive Engineer, Stores Division, Pochampad.
4. In the circumstances reported by the Chief Engineer, SRSP, in his letter 2nd read above, Govt. after careful examination of the proposal hereby direct that the powers delegated in G.O.Ms. No. 450, Irrgn (PW) Dept dt. 12-11-82 to the Executive Engineers of W&M-Divisions be extended to the Executive Engineer, stores division, Pochampad.
5. This order issued with the concurrence of the Finance and Planning (PW) Dept vide their U.O. No. 135-F IV (1)/90, dt. 12-2-90.
