Your attention is invited to the reference cited, wherein it was requested to supply a copy of G.O.Ms.No. 226 MA dated 17-06-2004 as also guidelines issued to Executive Engineers of Construction Divisions & Quality Control Divisions to ensure quality of works executed and certificates to be furnished in payment of intermediate and final bills. This information is still not received. Because of it, the Pay & Accounts Officers could not be suitably advised. A copy of the letter of Executive Engineer, Quality Control Division, Visakhapatnam addressed to this office is sent herewith. This letter is not received in this office. But it was received from Joint Director of Works Accounts, Dowlaiswaram on 23-02-2006. The Executive Engineer is requested instructions to be issued to the Pay & Accounts Officers not to admit bills, "till positive quality control remarks and clearance is issued" by him. This is vague and not clear.

You are therefore requested to immediately furnish the guidelines. The Executive Engineers constructions Divisions may be instructed not to present part & final bills to Pay & Accounts Officers, Assistant Pay & Accounts Officers without Quality Control certificates. The following points are to be clarified.

- The officer who is authorised to issue certificates and the form of certificate to be recorded in M.Book by the S.O/D.E.E./E.E. of Construction Division.
- The monetary limits, if any prescribed.

If no reply is received by the Pay & Accounts Officers/Assistant Pay & Accounts Officers will be asked not to make payment of any bill of any contractor from 1-3-2006.
