ORDER:

In the G.O. 1st read above Govt issued orders for considering tender premium up to 5% for R&B works by a Committee of R&B Chief Engineers on Ist call itself, for the present working season i.e. up to 30.06.2007 and accordingly in the G.O 2nd read above, Govt. constituted the Committee of R&B Engineers-in-Chief/Chief Engineer.

2. The Engineer-in-Chief (R&B) Admn. & Roads in his letter 3rd read above has requested the Govt to allow 5% excess tender premium on par with the other Engineering Departments beyond June 2007 without any time limit and to withdraw the G.O.Ms.No.243 and 244 of T.R & B(R.I) Dept., Dated: 08.03.2007 and to permit the respective tender approving authorities to approve the tenders as per the earlier tender approving procedures.

3. Government after careful examination of the matter hereby order to allow 5% tender premium on par with the other Engineering Departments beyond June 2007 without any time limit, and dispense the orders issued in G.Os Ist and 2nd read above and also to permit the respective tender approving authorities to approve the tenders as per the earlier existing tender approving procedures.

4. The Engineer-in-Chief (R&B) Admn. & Roads shall take necessary action accordingly.

5. This order issues with the concurrence of Finance Department vide their U.O.No 8746/855/A2/Expr. PWI/07, Dated:07.08.2007.
