1. G.O. Ms. No. 115 Revenue (L.R-3) Department, dated. 13-02-2001.

ORDER:-

The following amendments are issued to the G.O. Ms. No. 115, Revenue (L.R-3) Department, dated the 13th February, 2001.

I (i) In the said orders in paragraph 6 (i) in sub-paragraph (ii) for the works.

"Out of Rs. 200/- per acre collected towards water tax, Rs. 100/- representing 50% of tax would be adjusted to the Government Account to meet the cost of establishment etc.," the words.

"Out of Rs. 200/- per acre, collected towards water tax, Rs. 100/- representing 50% of tax would be adjusted to the Irrigation & Command Area Development dept, for meeting the requirements of the Department "And for the words "major Medium and minor" the words "major, Medium and Minor the water tax adjustment for the crops other than wet crops shall be in the same ratio as followed for wet crop shall be substituted.

(ii) For sub-paragraph (iii), the following shall be substituted namely:-

"(iii) Based on the actual collection, MRO shall demarcate arrears and current collections and arrange adjustment every quarter by issuing proceedings indiosting the amounts due to (i) irrigation & command area development department which comprises of the total arrears collections in respect of all the irrigation sources and 50% of the current collections in respect of Major & Medium irrigation sources i.e., Rs. 100/- out of Rs. 200/- collected) (ii) Water Users Associations (iii) Distributory Committees (iv) Project Committees and (v) Gram Panchayats within one month of the end of quarter. The MRO shall remit all the collections in favour of PAO/APAO to the head of account "MH-8782 - Cash Remittances - MH 102 - PW Remittances -SH 01 – Remittances and send the challan along with the proceedings to the concerned Pay and Accounts Officer/Assistant Pay and Accounts Officer who is in charge of releasing payments to the Division under whose jurisdiction the farmers organizations are functioning. The concerned PAO/APAO shall take the challan to the credit of MH-0701 (Revenue)/MH.0702 (Revenue)" as the case may be and issue cheques in favour of WUAs/DCs/PCs/GPs as per the allocation given by the Mandal Revenue Officer. The amounts relating to arrears of water tax and irrigation share as specified in (i) above shall be taken to "MH 8443 – Civil Deposits – Public work deposit (sub-head to be opened)' and kept in favour of the Commissioner, CAD.,

Hyderabad. The Commissioner, CAD., Hyderabad shall administer this fund as per the directions of the Govt. to be issued from time to time."

(iii) For the opening portion of sub paragraph (iv) the following shall be substituted namely:

"(iv) During the current year i.e., Fasli year 1410, it is ordered that the current water tax collections only are to be adjusted and the arrears be kept with the Govt. separately as sinking fund, which can be utilized for meeting the states matching share of functional grants to WUAs and other specific items as instructed by the Govt. from time to time. This arrangements shall continue till further instructions."

(iv) After sub-paragraph (v) the following sub-paragraph shall be added namely:

"(v) The adjustment of the water tax where Farmers Organisations are not functioning for any reason shall be made to the irrigation Dept. which will taken-up necessary O&M work as per the departmental rules and procedures in vogue".

II. For paragraph 7, the following shall be substituted namely:

7. The adjustment of current water tax collections are to be made in the following ratio for the period mentioned.
