At present the private vehicles are being hired at the rate of Rs. 10000/- per month including POLS, Driver Batta with coverage of 2500/- KM ceiling per month in terms of Government Memo first cited. The Engineer-In –chief (AW) in his letter dated 2.11.2002 has stated that the Board of Chief Engineers, in its meeting held on 14.6.2002 have decided the issue of enhancement of charges in respect of hiring vehicles, since the charges fuel, driver Batta, and maintenance charges with coverage of 2500 KMs per month of Rs. 10000/- are not sufficient. Hence the Board has recommended to enhance the amount from Rs. 10000/- per month to 12000/- per month with the same coverage of 2500 KMs per month and sought orders enhancing the monetary limit towards hire charges of inspection vehicles from Rs 10000/- to Rs 12000/- for covering mileage of 2500 KMs per month.

The above matter has been examined by the Government and after careful consideration has been decided to increase hire charges of private vehicles upto a maximum of Rs 12000/- per month, subject to following the condition laid down by the Government Memo first cited and also to meet the expenditure within the budget provision.
