**ORDER**

1. In G.O. Ms. No. 192 I & CAD (PW) Department, dt. 17-12-1995, order were issued enhancing the monetary limit for entrustment of unskilled nature of works on nomination from Rs. 50,000/- to Rs. 2,00,000/ for the year 1995-96 subject to certain conditions laid down therein to the beneficiaries (with preference to ayacudars/farmers). The validity of the above G.O. was extended from time to time upto 31-3-1998 in the G.Os., second and third cited above.

2. The Engineer-in-Chief in his letter 4<sup>th</sup> read above, was submitted proposals for extension of the orders issued in the G.O. third read above for one more year i.e., from 01-04-1998 to 31-03-1999 for entrustment of all unskilled works to water users associations and to the Ayacudars/Beneficiaries on nomination basis by the Executive Engineer upto Rs. 1.00 lakh and Superintending Engineers upto Rs. 2.00 lakhs wherever water users associations are not formed.

3. The Government after careful examination of the proposals of the Engineer-in-Chief (Irrigation Wing), hereby extend the validity of G.O. Ms. No. 15 I&CAD (PW-COD) Department, dt. 9-2-1998 for a further period from 1-4-1998 to 31-3-1999 for entrustment of unskilled works on nomination basis to the water users associations/Ayacudars or Beneficiary Committees.
