In view of the reference cited, it is to inform that in the QC manual Para - 3 indicates minimum No. of inspections to be done by the various inspecting officers and Para - 6 indicates that all the bills shall be accompanied by QC Certificates.

In this regard it is to inform that there can be any No. of Q.C. inspections before the submission of a bill (subject to minimum No. of inspections as per Para-3 of the manual) However there will be one quality certificate based on the Q.C. inspections with every bill. Proforma of Q.C. certificates is also annexed in the Q.C. manual. The para-3 is meant for internal guidance of inspecting officers of department and Pay and Accounts Officers need to be concerned with para-6 only. i.e. each bill to be accompanied Q.C. Certificate. This can be reviewed, if necessary after implementing and feed back from field Officers and Assistant Account Officers in due course.
