State as well as the Corporations under their administrative control include the condition of contribution of 0.25% from the Contractors gross bills, as their contribution to the National Academy of Construction by including it as a condition in the Tender Documents and Agreement Forms thus making such contribution mandatory.
- 3. The Builders Association of India in the meeting held on 30-8-2004 with Hon'ble Minister of Panchayat Raj, Irrigation, Roads & Buildings and Commercial Taxes on streamlining tender procedure for timely completion of works is agreed that in the interest of the State they have no objection to their contribution to being apportioned.
- 4. After careful examination of the request made by the Builders Association of India, A.P. Centre, Government hereby order that the present 0.25% contribution from the Contractors continue and be divided between Chief Ministers Relief Fund and National Academy of Construction in the ration of 0.15% and 0.10% respectively with immediate effect.
