ORDER:

The Andhra Pradesh, Social Welfare Tribes Advisory Council (APTAC) in its meeting held on 29-5-98 has made the following recommendation that the orders issued in G.O. Ms. No. 30, Social Welfare (V2) Department dt. 17-2-1994 may be modified providing for entrustment of the following categories of works on open tender basis.

- i. All buildings having outlay of more than Rs.5.00 lakhs
- ii. All minor irrigation works where the value is more than Rs.10.00lakhs
- iii. All B.T. Road works
- iv. All culverts/bridges having a span of more than 10 feet or 3 meters.

All the remaining works shall be executed only through the village tribal development agencies (V.T.D.As.).

- 2. The Commissioner of Tribal Welfare has forwarded the recommendation of Andhra Pradesh Tribes advisory council meeting dt. 29-5-98 to the Government for taking necessary action.
- 3. In the circumstances reported by the Commissioner of Tribal Welfare in his letter second read above and in the light of the recommendation of Andhra Pradesh Tribes Advisory Council received with in the reference forth and sixth read above, the following modification orders are issued to the order issued in G.O. first read above.

4. Para No.3 of G.O. Ms. No. 30, Social Welfare (V2) Dept. dt. 17-2-94 is a repetition (Para No.3 was twice incorporated in the said G.O., therefore.

Para 4 and so on till para 7 and the following shall be incorporated after the existing revision contained in para 4 of G.O. Ms. No. 30, Social Welfare (V2) Dept., dt. 17-2-94.

- 5. The following categories of works be entrusted on open tender basis.
- 1. All buildings having outlay of more than Rs.5.00 lakhs.
- 2. All minor irrigation works where the value is more than Rs.10.00 lakhs.
- 3. All B.T. road works.
- 4. All culverts/bridges having a open of more than 10 feet or 3 metres.

All the remaining works shall be executed only through village Tribal Development Agencies.
