### **ORDER**

In the Government order first read above orders were issued that tenders and tender notices in respect of all works costing of Rs. 5,000/- and above in the Irrigation Department have to be, Published in a weekly journal, "Tender Digest of Andhra Pradesh".

- 2. In the reference second read above, the Engineer-in-Chief, has requested to enhance the lowest limit of publication of tenders from Rs. 5,000/- to Rs. 10,000/-.
- 3. On this a suggestion was made to the Engineer-in-Chief that instead of enhancing the limit from Rs. 5,000/- to Rs. 10,000/- in general, the concerned Chief Engineers may be empowered to give relaxation in respect of such of these works which are considered to be urgent and require exemption from the publication in the "Tender digest of Andhra Pradesh" in view of escalation of costs. The Engineer-in-Chief was requested to place the matter before the board of Chief Engineers and obtain their considered views. The Engineer-in-Chief has reported that the Board of Chief Engineers have accepted the suggestion of the Government in its meeting held on 2-7-1985.
- 4. The Government after careful examination hereby delegated powers to all the Chief Engineers under the administrative control of Irrigation and C.A.D. Department and Irrigation & C.A.D. (P.W.) Department to exempt from publication of Tender Notices in the "Tender Digest of Andhra Pradesh" in respect of works costing upto Rs. 10,000/- (Rupees ten thousands only), if they consider them as urgent.
- 5. This order issues with the concurrence of Finance and planning (P.W.) Department vide their U.O. No. 294/F.VI/68-1, dt. 29-6-88.

- ii) The tenderers shall be asked to quote for the basic rate of excavation of each type of the four classifications of soils mentioned in item No. (i) above and also for the leads and lifts separately to the extent required for the excavation upto the full depth.
- iii) The tenderers shall be asked to quote their rates for each lift upto (a) the first six lifts (b) from seventh upto 10<sup>th</sup> lift and (c) for the lifts in excess of the first ten lifts. Similarly, they should quote their rates for each lead upto (a) the first six leads (b) from 7<sup>th</sup> lead to 10<sup>th</sup> lead and (c) for leads in excess of the first ten leads.
- iv) As regard the tender evaluation, certain quantities under each type of soil should be assumed by the department, as other wise each tenderer may assumed different quantity for a particular type of soil and there will not be any common ground for purpose of comparison. The tender schedule should, therefore, indicated clearly the quantities estimated by the department, under each type of classification on based on trial pits for the purpose of tender evaluation and comparison.
- 5. The Government accept the recommendations of the Project working committee for Nagarjunasagar Project as contained in para-4 above, and direct that they should be implemented in Nagarjunasagar and Pochampad projects with Immediate effect for one year after which it will be reviewed again.
- 6. This order issues with the concurrence of the Financial Adviser, Projects, vide his U.O.No. 3110/F.II(1)76-1/18-5-76.
