Through the ref. 1st cited, detailed guidelines were issued for planning and execution of works for the financial year 2017-18 under MGNREGS with the list of permissible works.

Through the ref. 2nd to 4th cited, the Project Directors, DWMA of SPS Nellore, Prakasam & West Godavari Districts have proposed certain works for creating sufficient shelf during the planning process.

In this regard, work wise clarification is hereby given for further implementation of MGNREGS.

Sl.No.	District	Request made	Clarification
1	SPS Nellore	Closure of small pits, abandoned wells etc.,	By ascertain necessity of work, these works may be generated under Area Specific works and pushed to Director login. To generate estimates to these works, pre measurements shall be taken and inputs shall be given for the actual quantities.
2	Prakasam	Requested sandy soils for the works "Filling of low lying and water logged areas in housing colonies/village common areas".	As per the GO.No.19 (Industries & Commerce (Mines II) dept, dated 15.01.2016, sand is not permitted for filling. Hence not possible to provide sandy soils in existing software.
3	West Godavari	Utilizing desilted earth in MI tanks for leveling of house sites, burial grounds, school grounds.	Leveling of house sites and leveling of burial grounds under Land Development Project in community lands and leveling of public institutions under PIDP Project are permitted works under MGNREGS. For these works, silt can be conveyed from MI tanks, as source for the works.
		Requested permission for desilting of farm ponds to an extent of 2430 Cum.	Desilting of farm ponds not permitted as per the MGNREGS guidelines. Hence further generation of estimates is disabled.

	Permission requested to take up removal of Gurrapu dekka once in every six months.	Para 4(2) of MGNREG Act says "works which are tangible, not measurable and repetitive works shall not be taken up under MGNREGA." In view of this cannot be permitted removal of gurrapu dekka twice in a year.
	Requested permission to bring earth at least from a distance of 3 km or below for formation of gravel roads where earth not available both sides of road.	If conveyance allowed, material component may be crossed. Hence to maintain 60:40 only, permission is given for the utilization of silt by using head loads. Total quantity also divided as 66% with head loads and 33% with conveyance.
	Provision requested for the room of watchmen and tank in Solid waste management work under MGNREGS.	These provisions may be taken up under convergence with Panchayat Raj.

Hence all the Project Directors, DWMA are requested to make note of the above and identify the works as per the field requirement and ensure quality shelf of works is made available as per the requirement.
