The Government in Industries & Commerce department vide reference 1st cited has issued instructions that Sand must be made free for all Public for the purpose of construction of buildings other than for filling purpose. Sand should not be stored in excess, which attracts penal action on the concerned.

Subsequently, the issue was proposed by the Technical Advisor, P.R. Department for discussion in the Board of Chief Engineer's meeting. The Board of CEs vide ref 2nd cited, discussed the issue and decision taken for revision of rates of Sand w.e.f. 2-3-2016. The details are mentioned as follows.

As the instructions came into force w.e.f. 02-03-2016, all the PAO/APAOs are instructed to note that.

- 1) These rates came into force w.e.f. 02-03-2016. The Quantity of sand utilized on a particular work after that date has to be worked out and the difference cost on sand has to be deducted from the bills.
- 2) The overhead charges and contractors profit provided extra also to be deducted accordingly.
- The deduction portion is applicable for all the works wherever sand is being utilized, and a statement of recovery in detail shall be enclosed by the DDOs for all the bills presented by them. This may be watched by the PAO/APAOs while admitting the bills.
- 4) For new works sanctioned after 02-03-2016, the data may be verified for its conformity with the new rates, and estimates may be called for revision wherever
- 5) The JDWAs may make a note of this point during their review of estimates and agreements.
- The PAO/APAOs may circulate these instructions among all the DDOs with a request to submit the bills with revised sand rates for all the works wherever sand is utilized after 02-03-2016.
