ORDER:

In the reference 1<sup>st</sup> read above, Government have issued amendment to A.P. Treasury Code duly replacing S.R. 2(s) under T.R. 16 as "Every receipt for a some exceeding Rs.5000/- shall be duly stamped by the payee with a one rupee Revenue Stamp, subject to the exemptions etc., listed in Appendix-11".

2. In the reference 2<sup>nd</sup> read above, Government have issued orders exempting the Resettlement & Rehabilitation Department from the orders issued in the reference 1<sup>st</sup> read above, for the purpose of making payments to the Project Displaced Families (PDFs) and Project Affected Families (PAFs) as a special case.

3. In the reference 3<sup>rd</sup> read above, Government have issued orders exempting obtaining of stamped acquittance / advance stamp receipt in respect of making payments to the Land Acquisition cases, since all the Land Acquisition payments are being made to their Bank Accounts, as a special case.

P.T.O

4. In the reference 4<sup>th</sup> read above, the Director, Works and Accounts, A.P., Ibrhimpatnam has informed that all the payments are being made online and credited to the respective beneficiaries bank accounts. Therefore he has requested the Government to exempt the Advanced Stamped Receipt and Stamped Acquittance in respect of all the on-line payments credited to the beneficiaries bank accounts.

5. Government after careful examination, hereby exempt for obtaining the Stamped Acquittance / Advance Stamp Receipt in respect of all the payments made on line and credited to the respective beneficiaries' bank account.

6. The Director of Treasuries and Accounts, Director of Works Accounts and Pay & Accounts Officer, Ibrahimpattam shall take necessary action in the matter.
