ORDER:

The Engineer-in-Chief(R&B) SH & MD., APRDC, in his letter 3rd read above has stated that, the Government accorded administrative sanction vide G.O.Rt.No. 6 of T, R&B (R.IV) Department, dt. 07.01.2019 under Corenet capital head for the year 2018-19, stipulating certain systemic improvements, while executing the said sanctioned works. The Engineer-in-Chief has further stated that the Hon'ble Supreme Court in its judgement dated 30-11-2017 in WP (civil) No 295/2012 ordered that road safety audit shall be conducted for all new road projects of length more than 5.00 Km including the design stage audit. Hence, he has submitted that road safety audit is mandatory for all new road projects/capacity augmentation projects, having length more than 5.00 Km, prior to (design stage), during construction and after construction as per the directions of the Hon'ble Supreme Court. The Engineer-in-Chief (R&B)SH&MD., APRDC has requested to include a condition for Road safety Audit under the head of systemic improvements in compliance with the directions of the Hon'ble Supreme Court and also to carryout Road Safety audit during design stage during and after construction.

- 2. Under the circumstances reported by the Engineer-in-Chief (R&B) SH & Managing Director, APRDC in his letter 3rd read above and after careful examination of the matter, Government hereby order the following:
 - a. Road Safety Audit shall be conducted on all road capacity augmentation projects/new projects having length more than 5Km, during design stage, during construction and after completion of construction
 - b. Approval of the Road design shall be done duly considering the road safety Audit reports done at the design stage.
 - c. All Road Safety measures shall be under taken by the Agency during construction as per Road Safety Audit Report.
 - d. The Final bills shall be paid only after compliance with Road Safety Audit after completion of construction.
- 3. These orders shall be applicable to all the road works in the R&B Department, MA& UD Department and PR & RD Department with prospective effect.

- 4. All the HoDs in the address entry, shall take further necessary action in the matter accordingly.
- 5. This order issues with the concurrence of MA&UD Department and PR&RD Department.
